IMMEDIATE BURIAL

The charge for immediate burial includes basic services of funeral director and staff, removal of remains, local transportation to the cemetery and necessary authorizations. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial, nor does it include any cemetery property, opening and closing of the grave, grave liner, vault or burial marker.

DIRECT CREMATION

The charge for direct cremation includes basic services of funeral director and staff, removal of remains and local transportation to crematory. **This charge does not include the ceremony fee or use of facilities and staff for any visitation or ceremony, public or private, prior to the cremation.** If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without outside covering). The containers we provide are corrugated fiberboard cremation containers (cardboard) and a selection of wood cremation caskets.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$ 1,695.00 •

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice and coordination with those providing other portions of the funeral, e.g.: cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory costs, recordkeeping, secretarial and administrative expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charge for direct cremations, immediate burials and forwarding or receiving remains.)

EMBALMING

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

ADDITIONAL SERVICES AND FACILITY FEES

Our services will include visitation setup, placement of encased remains, displaying floral arrangements, parking lot assistance, supervision and attendance during the visitation.

The remains will be displayed as they arrived (with no restorative or cosmetic procedures done) at the crematory, and inside the fiberboard cremation container. F. Private Family Identification View. This provides one last opportunity to say goodbye to your loved one and includes bathing, dressing, and cosmetising of remains. The remains are placed on a cot (wheeled gurney) in the chapel of the funeral home and covered with a sheet and blanket. This is limited to immediate family only, limited to ten (10) persons and for up to 30 minutes. This does not include embalming or services. **\$350.00**
